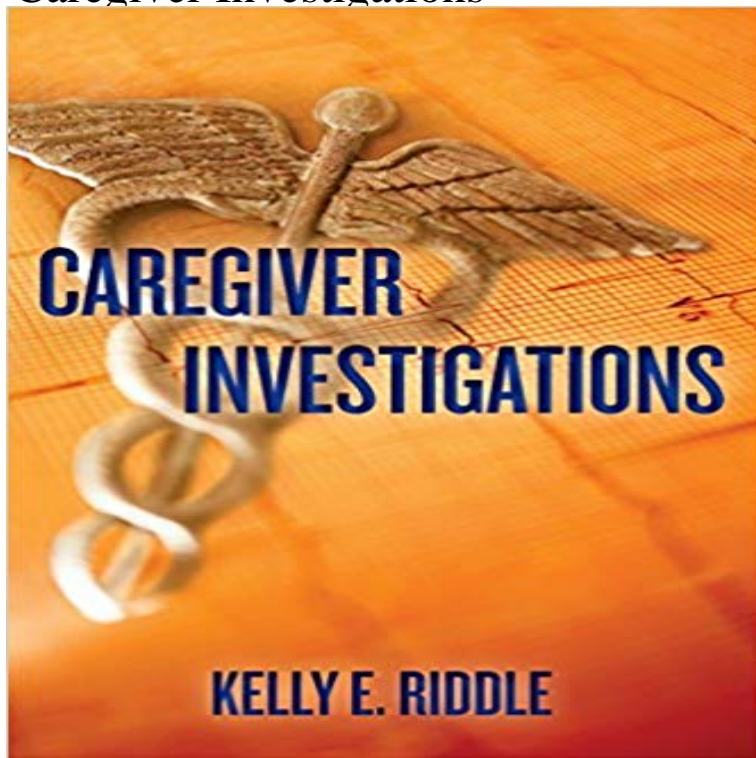


Caregiver Investigations
