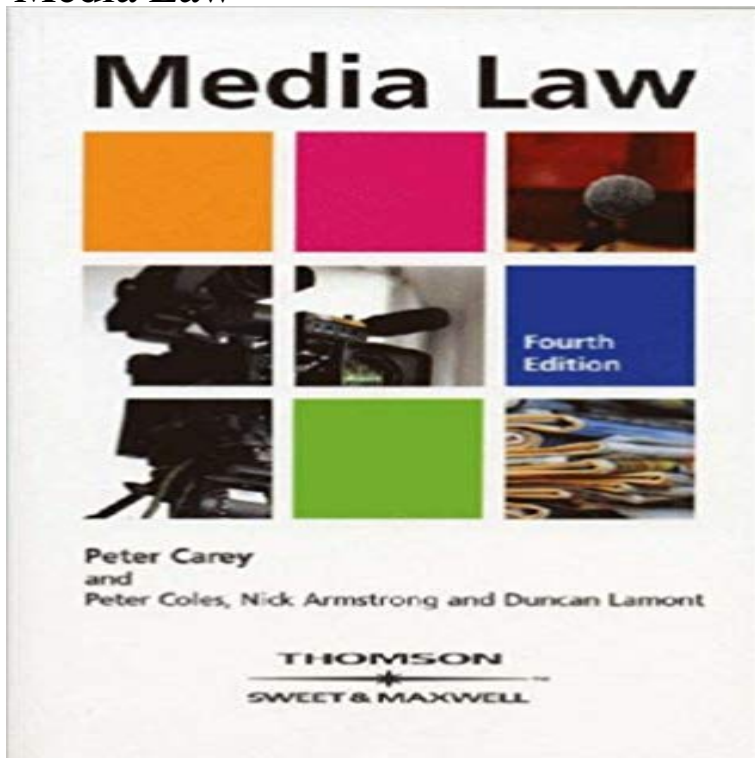


Media Law
