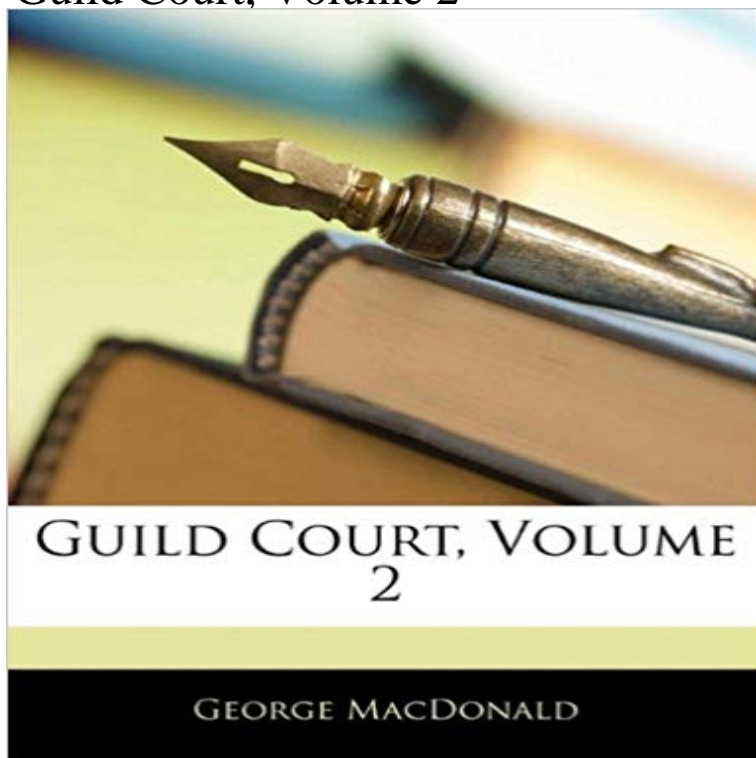


Guild Court, Volume 2
