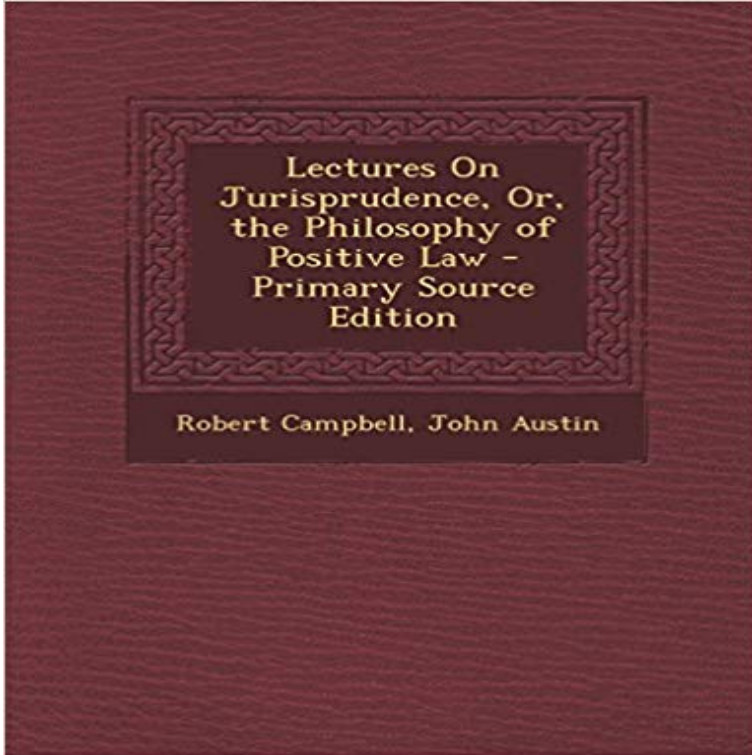


Lectures on Jurisprudence, Or, the Philosophy of Positive Law - Primary Source Edition
