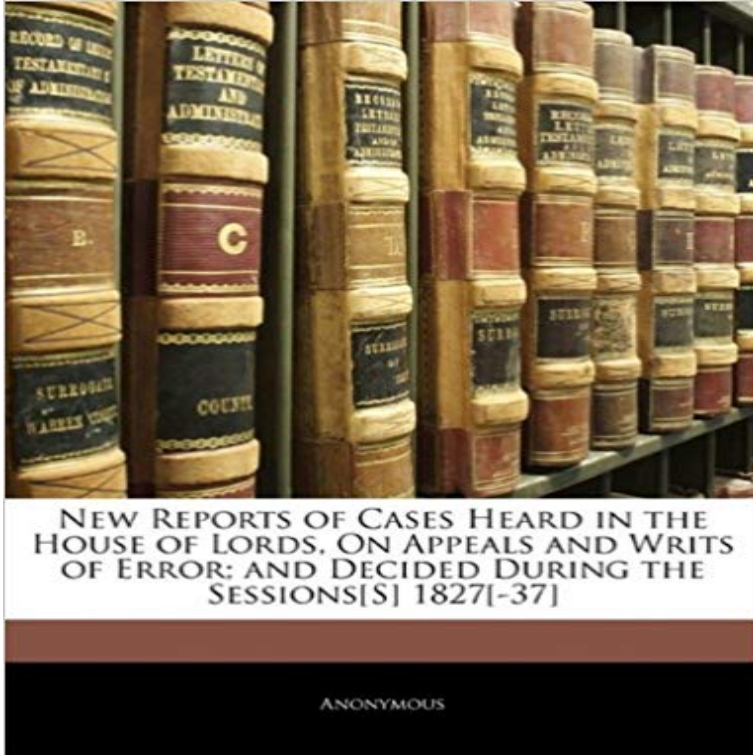


New Reports of Cases Heard in the House of Lords, On Appeals and Writs of Error; and Decided During the Sessions[S] 1827[-37]
